Atlanta Preschoolers Included in Odyssey School-Based Counseling Program

Among the many schools that partner with Odyssey to provide behavioral health services, one school stands out for its unique student body. Premier Academy is a Center of Excellence daycare center for young children six months through five years old. Its goal is to ensure that all children who enroll are developmentally ontrack and prepared for success in kindergarten. The school partners with Odyssey to provide counseling services to their struggling three to five-year-old students. Odyssey counselors, along with teachers and administrators, work directly with each child to ensure positive academic, social, and developmental outcomes are achieved. Our counselors provide parent training and teacher observation in the classrooms. They also participate in parent/teacher home conferences.

Since Odyssey Family Counseling Center's founding in 1972, our philosophy and mission have been simple: improve the lives, and often save the lives, of low-income and underserved individuals and families who suffer from mental health and substance abuse challenges. We are a unique and long-standing non-profit community counseling center located in the heart of South Atlanta. This is where we have made our lives, where we grow, and where we strive to offer a healing space within the Atlanta community. Most importantly, we welcome all who walk through our doors empowering people living with mental illness the tools and support they need to develop their own path to living with independence and dignity. In the wake of COVID-19 and the guidelines outlined by CDC with school closures, businesses and restaurants being shuttered, people losing their jobs, markets tumbling, social distancing, and not to mention the anxiety of possibly getting sick, Odyssey continues to prepare currently and for its aftermath.

Odyssey's staff has continued to work tirelessly to address the needs of our clients: children, adults, and families. While certain things have been put on hold, we acknowledge that life continues.

We also recognize that there will be a "second wave" of huge need. Officials and professionals in all fields have been discussing it... the mental health wave crisis expected to result from isolation and the new normal. Everyone's mental health will be affected. The potential for increased suicides, incidents of domestic violence, substance abuse and child abuse during the pandemic is high. Anxiety, depression, stress, and substance dependency will be on the rise and worse for some than others. We will need more well-trained mental health professionals in addition to prepared leaders to guide us through.

Odyssey is remaining steadfast through the public health crisis and will continue through the second wave – the mental health crisis. We have already seen an uptick in the number of new clients calling needing assistance.

May L. is a 44-year-old African American female, who is self-employed, and

is the single mother of three sons. She is also a grandmother to one grandson. May initiated therapy services with Odyssey to address her symptoms of anxiety and depression stemming from unresolved issues of extensive trauma relating to her birth family beginning in childhood. She also experienced the brutal murder of her 21-year-old daughter approximately four years ago. May reported participating in therapy after her daughter's death but was unable to fully engage due to her immense grief and could not afford to continue counseling due to lack of insurance.

However, since beginning services at Odyssey, which are supported by foundation and donor funding, May reports that she has finally been able to begin a healthy grieving process. She has expressed her gratitude for the progress she and her therapist have made and is feeling hopeful for the future, for herself and her children and grandson. May continues in therapy at the time of this report.

Debbie T. is a 10 year-old Latina female

female and a fifth-grade student attending a Fulton County elementary school served by Odyssey's School-Based Mental Health Program (SBMH). The school social worker recommended that Debbie meet with our counselors. Debbie explained to the counselor that she had been sexually assaulted by a neighbor. She did not want to express her feelings or communicate with others, and was isolating herself from everyone including from classmates at school. She and her family did not have health insurance which prevented her from receiving mental health care.

Through grant funding supporting the SBMH specifically for students who are uninsured and under insured, Debbie was able to receive counseling at school. As a result, she is able to express her thoughts and feelings regarding the sexual assault and day to day issues. Debbie is now able to make friends at school and communicate more easily with her family and teachers. Debbie needs more time to recover from the trauma of the sexual assault and will continue seeing an Odyssey counselor when she returns to school in August.





S.W. has been receiving services since Fall 2019. They entered services due to their

experience in an abusive romantic relationship. S.W. struggled with severe anxiety and negative self-image related to the partner's abuse. Our client has been out of relationship for a year and is currently in a new, positive relationship. S.W. has reached many of their treatment goals, including a significant decrease in worrying, overthinking, and self-doubt. S. W. is moving toward transitioning out of counseling services due to their progress on the goals that were established and overall positive state of mind and wellbeing.

Odyssey Partners with the Atlanta Harm Reduction Coalition

To best provide prevention and treatment services, the Atlanta Harm Reduction Coalition, Inc (AHRC) and Odyssey Family Counseling Center (OFCC) entered a collaborative partnership in November 2018. The purpose of this effort is to implement comprehensive Substance Abuse and HIV prevention programs to reduce morbidity, mortality, and related health disparities, among African American Men who have sex with Men (MSM) ages 18-29 at high risk for acquiring HIV specifically with emphasis on reducing Substance Abuse, new HIV infection, increasing access to Substance Abuse and HIV medical care, and promoting health Equity.

The goals of the project are to prevent Substance Abuse and HIV/AIDS among at-risk African American MSM (18-29), and to ensure that African American MSM (18-29) living with HIV/AIDS or Viral Hepatitis receive needed services. Toward these ends, the six main objectives of the partnership include:

- 1. Increase risk assessment and development of an individualized risk-reduction plan that will assist in the decision process of getting tested for HIV, as well as preparation for delivery and interpretation of test results to at least 500 young African American MSM (18-29) including those who are homeless within the Atlanta area.
- 2. Increase knowledge and prevention skills in at-risk young African American MSM (18- 29) by providing evidence-based HIV and Substabce Abuse interventions to at least 100 unduplicated at-risk young African American MSM per annum.

- **3.** Increase awareness of HIV infection and Substance Abuse through strategic media campaigns to reach at least 2500 unduplicated at-risk African American MSM (18-29) per annum. This will utilize comprehensive peer driven social media and advertisement strategies.
- **4.** Increase HIV and Substance Abuse education and safety skills by conducting educational outreach and condom distribution to at least 1000 unduplicated at-risk African American MSM per annum.
- **5.** Increase access of HIV/AIDS treatment, HCV treatment, and SA treatment for 150 (2% HIV, 10% SA, 3% VH) unduplicated atrisk young African American MSM (18-29) identified through testing, outreach.
- 6. Increase Substabce Abuse treatment by providing medication assistance and counseling to at least 15 SA African American MSM (18-29). Our target population is African MSM (18-29) who have traditionally been the most disconnected from services and the hardest to reach, including those who are impoverished, homeless, and substance using.

By fully integrating our services, our program will reach and assist populations that have fallen through the cracks of traditional fragmented service delivery systems, thereby increasing system capacity to effectively prevent SA and HIV/AIDS, and provide better access to care. This collaboration has led to additional partnerships and referrals with several agencies Thrive SS.

I was initially attracted to join the Board because of Odyssey's reputation of being "one of the best

kept secrets" in the Metro Atlanta area among mental health professionals because

of the excellent work they were doing with their clients. Now, some 6 years later, and as a Past Board Chair, I have

witnessed Odyssey's continued growth in the provision of needed services and expanded

impact in the local and surrounding community. A secret no more.

Engaged who improved functioning AEB decreased TD scores on SDQ



HIGHLIGHT: CENTER FOR BLACK WOMEN'S WELLNESS PARTNERSHIP

Odyssey Family Counseling Center provides mental health services to the Center for Black Women's Wellness for participants in their Wellness and Safety Net clinics. The Center is located in the Mechanicsville neighborhood in southwest Atlanta. Services provided by Odyssey include weekly individual counseling sessions and monthly psycho-education groups that focus on behavioral health and wellness-related topics. Both clinics provide low-cost preventive and women's healthcare services in addition to chronic disease management. Women are given mental health screenings during clinic visits and referrals are made to Odyssey based on results. Some concerns and challenges that most clients face are experiences with childhood/adult trauma, depression, anxiety, mood disorders, intimate partner abuse, and chronic physical health issues that impact mental health. In addition to medical and behavioral health services, CBWW also provides medication management which results in full integrated healthcare services for clients in need. Odyssey and CBWW began this partnership in March 2017 and since that time has provided therapy services to 58 women. Participants are 97% African American women who are uninsured with a median income under \$27,000. In FY 2019, Odyssey provided services for approximately 20 women, in FY 2020, approximately 24 women we served.



Pam Braxton, a Licensed Clinical Social Worker, is the lead therapist who provides therapeutic services to clients and is also the marketing coordinator for OFCC. She received her Master's Degree in Social Work from Kennesaw State University. As a therapist, Pam has a broad scope of therapeutic experience including working with children, adults, adolescents, families, couples and groups. She provides a safe, supportive,

and non-judgmental environment where clients can explore their concerns and use their strengths to formulate strategies to achieve their goals and objectives.



My therapist is very involved with my treatment and sensitive to my problems. She's great and Hove that I can come to the center to get medical attention and counseling in the same place. It is very convenient. I have made a conscious decision to change my negative thoughts and I think more about my future. The old me is coming back where I was happy, and my life was fulfilled. I like coming to counseling talking to someone who doesn't judge me or make me feel bad about myself and really wants to help me. I still think I have a long way to go but I'm on my way.

Federal Client Program

Odyssey began seeing clients under the Federal Client Program (FCP) in November 2019. Under FCP we service those clients that are currently being supervised by a Federal Probation Officer after being released from prison. These clients either had a previous mental health diagnosis prior to their sentencing and incarceration or they have demonstrated a need for mental health services during the pretrial process. Additionally, all clients have been ordered by a Federal Judge to receive a mental health evaluation and treatment. Clients may have also received mental health services and medication management while incarcerated and OFCC is serving as their wrap around provider. Odyssey provides individual counseling, dual diagnosis and medication management services for our FCP clients.

Odyssey has been a great assistance to the persons under supervision that we oversee and helps to assist in the re-entry of our probationers to the community.
